



## 2010 MQHA STALLION AUCTION Stallion Breeding Agreement

I agree to donate one breeding to the Missouri Quarter Horse Association's stallion auction for the following stallion for the 2010 breeding season:

### TERMS

1. The breeding season runs from February 1 to June 30, unless otherwise specified.
2. **The current advertised fee for this stallion is \$ \_\_\_\_\_** (bidding will start at one-half of the advertised fee plus an administrative fee of \$35.00 - Minimum \$235.00).
3. Stallions with no advertised fee will start at \$335.00.
4. Stallions not purchased at the auction may be purchased for one-half the advertised fee plus \$35.00 (minimum \$235.00) on a first received, first sold basis.
5. A live foal is guaranteed only to the extent of one return breeding the following year (the same or a substitute mare), and then only by the initial purchaser of the breeding.
6. Should the above-named stallion die or become unfit for breeding purposes, then any monies paid by the mare owner to the Missouri Quarter Horse Association shall be refunded in the form of credit for use in future auctions, upon proper verification from the stallion owner. There will be no cash refunds.
7. Mares shall be halter broken. Additionally, the mare shall be in a healthy and sound breeding condition. A photocopy of both sides of the mare's registration papers, a current coggins, and a veterinarian's health certificate shall accompany the mare.
8. A breeder's certificate shall be furnished to the mare owner when the foal is on the ground and upon payment in full of all board and other expenses owed to the breeder.
9. Any and all expenses arising out of or relating to this breeding shall be the sole responsibility of the mare owner, including without limitation mare care, boarding fees, veterinarian fees, collection fees, chute fees, shipping fees, container deposits, and any other associated expenses.
10. Participants acknowledge and agree that the Missouri Quarter Horse Association shall not be responsible for any expenses or damages whatsoever arising out of or relating to the breeding, including without limitation, either the mare or stallion owner's participation in this auction or performance under this agreement. For that reason, bidders should contact stallion owners and become familiar with the breeding contract, terms, and expenses associated with any stallion service on which they intend to bid prior to placing a bid.

The signed contract will remain in effect until terminated in writing by the Agent/Stallion owner.
